TAMC FACTS

hether you are a local resident, business owner, employer or visitor, you depend upon us, the Transportation Agency for Monterey County (TAMC) to make our community better and safer by planning, funding and delivering transportation projects for Monterey County. We are a small regional agency overseen by a 23-member Board of Directors which includes each of the five county supervisors, a representative from each of Monterey County's 12 cities, and non-voting representatives from six public agencies, including Caltrans and the City of Watsonville. The composition of the Board ensures that every community has a voice and representation.

Collectively, our goal is to improve safety, relieve traffic congestion, and facilitate the movement of people and commerce to improve quality of life in Monterey County. Our projects vary in size and scope, ranging from a large highway or rail project to a small neighborhood sidewalk or bike trail.

TRANSPORTATION SAFETY & INVESTMENT PLAN

Thank you for your vote of support, Monterey County!

our vote to invest in your community by approving a 3/8% sales tax, dedicated to improving Monterey County's transportation network, has elevated Monterey County to self-help status. Being a self-help County will enable us to leverage state and federal matching funds to enhance our ability to fix our roads and improve safety, access and mobility for all who live, work and visit our beautiful county. These funds are even more critical as we face the challenges presented by the damage caused by storms this winter season.

The sales tax goes into effect on April 1, 2017, and it is expected to raise an estimated \$20 million annually, for \$600 million over 30 years. 60% of the funds will be distributed to local cities and the county for road maintenance

and safety projects. The remaining 40% will be used for regional mobility and safety improvements.

The Transportation Safety & Investment Plan is a fair, balanced and equitable plan designed to meet our local and regional needs. The chart on the next page illustrates the funding share dedicated to local road and safety repair, regional road safety projects and mobility.

The Plan was developed with the help of 40 community members. The projects identified on page 4 will be funded through the measure; and now that we are a self-help county, we will be able to leverage funding for the regional safety, mobility and walkablity projects in the Investment Plan.





Measure X for eXcellent Transportation

Before any of the projects in the Transportation Safety & Investment Plan are built, there are a number of policies and procedures that must be put into place to ensure that funds are utilized in the manner intended by the voters. These policies include agreements with the Board of Equalization and each of the cities and the County. While the sales tax will go into effect in April, the first revenue from the tax will not return back to us until late summer. As you might expect, the revenue will trickle in and build over time. Based upon the timeline below, we are optimistic that some of the smaller projects, such as those identified by your local community, can begin construction in the fall of 2017. Holman Highway 68 Roundabout Project

The Holman Highway 68 Roundabout Project is a landmark highway-to-highway roundabout that will relieve traffic congestion and improve safety near the Highway 68/Highway 1 intersection at the Pebble Beach gate. This project is designed to improve access to the Community Hospital for the Monterey Peninsula, Pacific Grove, Monterey and Pebble Beach. It is a public-private partnership between the City of Monterey, City of Pacific Grove, Pebble Beach Company, TAMC, the Monterey Bay Unified Air Pollution Control District, Monterey County, and Caltrans. Construction on the roundabout began after Car Week 2016 and is expected to open to the public later this year. SR 68 Scenic Highway Plan

TAMC secured funding from Caltrans to help evaluate how to improve traffic flow and safety on our primary commute corridor: Highway 68. Our Agency launched the SR 68 Scenic Highway Plan Study with a large community workshop in 2016. Staff and consultants are evaluating current and future travel patterns between Salinas and the Monterey Peninsula, looking into affordable projects that will make safety, operational and capacity improvements in the SR 68 corridor, as well as improve crossings for wildlife. Given that the SR 68 corridor is the top regional project in the Transportation Safety & Investment Plan, this study is an important tool for helping TAMC prioritize project elements and to leverage state and federal matching funds to stretch our local dollars to build as many improvements as we can. Via Salinas Valley

Via Salinas Valley: Pathways to Health through Active Transportation is a collaborative regional effort to improve health, access and safety in the Salinas Valley. TAMC partnered with the Monterey County Health Department to secure a \$4.6 million state Active Transportation Program grant to fund this project. Via Salinas Valley combines educational programs with capital projects such as sidewalks, safer crossings, bike lanes and paths to community destinations such as parks, schools and community centers in the five Salinas Valley cities: Salinas, Greenfield, Gonzales, King City and Soledad.

Highway 156 Improvements


Our agency initiated an in-depth study to evaluate whether drivers are willing to pay a toll to drive on a new four-lane "Monterey Expressway" to avoid heavy traffic on Highway 156. Significant additional revenue beyond what is traditionally available is needed to build a four-lane expressway parallel to the existing Highway 156 and a safer new interchange at U.S. 101. The current two-lane highway will remain untolled, and be available to the local community. The Measure X plan guarantees that regardless of whether a tollway is constructed a new, safer interchange at Castroville Boulevard and Highway 156 will be constructed. Castroville Bicycle/Pedestrian and Railroad Crossing Project

The groundbreaking ceremony for the *Castroville Bicycle/Pedestrian & Railroad Crossing* was held on Monday, December 12, 2016. The construction on this much needed project began on January 3, 2017 and is expected to be finished by the end of the year.

The project will construct a bicycle and pedestrian bridge crossing over the railroad tracks and a new path parallel to Highway 156. Students will have a much safer route from downtown Castroville to Elkhorn Elementary School and North Monterey County High School. The project also links to the regional Monterey Bay Sanctuary Scenic Trail via the Castroville path parallel to Highway 1. Salinas Rail Extension: Kick Start Project

Significant progress continues to be made on the exciting *Salinas Rail Extension: Kick Start Project*, which will revitalize downtown Salinas and bring new rail service to connect Salinas and the Bay Area. This project is at the forefront of a revitalizing effort that will greatly enhance mobility throughout the county by transforming an underutilized corner of downtown Salinas into a thriving rail and bus station that improves travel to the Silicon Valley.

Lincoln Avenue will be extended across Market Street to provide safer, signalized access for pedestrians, bicyclists and motorists to the train station. This road extension will better connect the historic train district to downtown.
